

CLM: THE CONTEXT



GENDER, GENDER-BASED VIOLENCE AND HUMAN RIGHTS COMMUNITY-LED MONITORING



Description:

This module aims to provide specific knowledge on how CLM can be used to eliminate gender barriers, combat gender-based violence, and protect human rights. Lectures that include theoretical materials and practical exercises would give learners insights into why it is crucial to have human rights-related and gender-oriented CLM in place for HIV-service and community-based organizations. By the end of the course, leaders, employees, and volunteers of civil society organizations will be equipped with the best practical tools and methods for human rights violations monitoring. Moreover, learners will have substantial knowledge of advocacy follow-up steps after CLM is held and where to use collected evidence to improve the quality of existing HIV services.



Objectives:

- ▶ To provide learners with an in-depth understanding of the specificity of CLM of human rights and gender-based violations for community-based and HIV-services organizations and to highlight how it differs from community monitoring of services provision;
- ▶ To equip leaders, employees, and volunteers of civil society organizations with basic knowledge on human rights and to provide them with real examples of human rights violations of key populations, collected within CLM;
- ▶ To develop advanced monitoring skills for gender-based violence, a solid understanding of why it happens, and how to react to it;
- ▶ To generate by the end of the course a specific advocacy action based on data collected by CLM, with the aim of improving the quality of existing HIV services.

Representatives from community-based organizations/networks will be able to initiate and conduct advocacy activities based on results of gender, gender-based violence, and human rights CLM.
